
INSTRUCTIONS


Install in accordance with national and local electri-

- cal codes
- Warning: Disconnect 1. power at electrical service entrance by removing fuse or switching circuit breaker to "OFF"

Note: Use only one dimmer with one 3-Way On/Off switch. Do not use two dimmers when using this Push On/Off model.

- Remove faceplate of old light switch.
- Remove screws holding old 3. switch to wall box without disconnecting wires.





- 4. Identify "common terminal" on "common" on case).
- 5. Disconnect the wire from the common terminal and connect to black (common) wire on dimmer.
- Disconnect remaining wires from old switch. 6
- Connect remaining wire leads on dimmer to remaining wires from old switch, noting color wire attached to each wire lead of dimmer (see diagram above).
- Mount dimmer to wall box with 2 screws.
- 9. Replace existing faceplate so that shaft protrudes through opening in the center of plate.
- 10. Push plastic knob onto shaft.
- 11. Restore power.

Wiring

- The insulation strip length: 3/8" for solid wires and 5/8" for stranded 1. wires
- 2. One piece of 18 AWG wire is intended to be connected to a 12 to 14 AWG wire by supplied connectors.
- 3. Supplied connectors for use with copper wire only.

Derating: When ganging two dimmers together, derate to 500 watts each, when ganging three dimmers together, derate to 400 watts each.

Caution: To reduce the risk of overheating & possible damage to other equipment, do not install to control a receptacle, a motor-operated appliance, a fluorescent lighting fixture, or a transformer-supplied appliance.
